## **Head lice**

#### **Dear Parents**

There has been an occurrence of head lice in your child's class/kindergarten. All parents are required to cooperate in this matter in order to prevent this from spreading further.

The presence of one tiny, crawling louse is hard to detect immediately, and it may be several weeks or months before you notice an infestation.

So that **you** spot an infestation of head lice as soon as possible, we ask you to examine your child's hair once a week for the **next 6 weeks** by wet combing as follows:

- Apply any hair conditioner generally available on the market. This will make it easier to comb the hair out and stops the head lice from escaping, as they become trapped in the conditioner.
- Now carefully comb the hair conditioner/treatment out with a special plastic nit comb, hank by hank, starting at the scalp and combing to the tips of the hair.
- Wipe the comb on a white tissue after each pass of the comb. Inspect the conditioner for nits (the size of a grain of sand) or lice (the size of sesame seed), using a magnifying glass if required.

## In the event of an infestation:

Should you find lice or nits, please buy a suitable product for the treatment of head lice. Use the treatment according to the instructions and wet comb the hair once again after application.

Your child will be able to attend school, etc., on the day after treatment, as they will no longer be at risk of passing head lice on.

None of the treatments can reliably kill off all the nits present, therefore it is **essential to carry out a second treatment exactly nine days after the first.** It is also necessary to comb out the hair using hair conditioner on the 5th, 9th, 13th and 17th day and wet comb the hair, including that of all family members, once a week to maintain a check.

If you find small "baby lice" or nits on the 5th day, please wait until the 9th day to carry out the next treatment, as there is no danger of passing these small lice on.

Please bear in mind that lice always lay their eggs directly on the hairline and that hair grows 1 cm per month; any nits found more than 1 cm away from the hairline do not indicate a new infestation of lice and require no further treatment. Nits that are found three centimetres away from the scalp will be 3 months old.

Please inform the parents of your child's friends of any infestation – it is known that head lice only spread by crawling from hair to hair, so transmission requires close head-to-head contact. Head lice <u>cannot</u> fly or jump, need an ambient temperature of 31°C and to feed on blood every two to three hours, and cannot survive off the human body.

Combs and hairbrushes should be cleaned and towels and bedding washed once, after which, according to current practice, no further washing and cleaning is necessary.

We do <u>not</u> recommend the use or application of oils, "natural" shampoos, "lice" washing detergent, room sprays or preventative products, as these are unnecessary.

Long hair may be gathered up and tied back by way of prevention, in order to limit the possibility of contact.

Parents <u>must</u> notify the school/kindergarten if an infestation of head lice is found (§ 34 Infection Protection Act).

A child infested with head lice is not allowed to attend school or day care centres.

All parents of children in the affected group/class must confirm in writing by return that they have examined their child for head lice, and that the child is free of head lice and nits – the child will not be allowed to attend without this confirmation.
